### Terms and Conditions of Hire

1. The owner will not be held responsible for any loss, accident or injury caused by use of the equipment.
2. The hirer will pay up front for the cost of the hire.
3. You and other group members will use the equipment in a skilful and proper manner and that all users have enough experience to manage the craft being hired safely. This means you will only use the craft with in your limits.
4. The hirer agrees to follow all rules related to safe boating and transport SA water safety. For example all people using the equipment must wear a personal flotation device.
5. You agree not to take the craft into restricted water access areas, such as the barrage / lock area.
6. You agree to use the equipment the agreed areas of use and not to transport the craft to any location using any form of vessel or vehicle.
7. You agree not to abandon the craft and or leave it un attended during your agreed hire.
8. You agree that all users of the craft are over the age of 10 and are accompanied by an adult.
9. You agree to stay in the restricted waterways when there is moderate wind conditions
10. You agree to stop using the craft when the wind is over 15 knots or lightening is present, taking the craft to shore.
11. You also agree to call the Emergency contact that will help recover the craft and a charge may be forwarded to you.
12. You are not to trespass onto other peoples Interaction with people's property
13. You agree not use the craft while influenced by alcohol or drugs
14. The Hirer shall pay a bond of \$300. This is to be held by the owner until such time as the equipment is returned in good order and repair. This bond will be held with the credit card slip.
15. Any monies required covering repairs to or replacement of any equipment shall be automatically deducted from the amount of the bond held.
16. When the value of such repairs or replacement exceeds the amount of bond held, the Hirer shall be liable for the total repair or replacement cost.
17. In the event of failure to return equipment to the owner's premises by the conclusion of the hire period you shall be liable for hiring fees equivalent to all subsequent periods of hire.
18. Any hirer who should wish to extend the period of hire booked shall notify the owner of their intent to do so and will be advised of the availability.
